



The Biggest Multi-Billion Dollar-Fertilizer Plant Comes On Stream In Bayelsa

The Executive Vice Chairman of the Brass Fertilizer and Petrochemical Company Ltd, Chief Ben Okoye says, the 3.6 billion dollars Fertilizer Plant Project is expected to generate 15,000 jobs charing the construction phase of the project and 5,000 permanent employment opportunities, when completed.

Cluef Okoye amounced this, while receiving the Certificate of Occupancy, (Cerf O) for the land allocated for the construction of the plant at the Brass Island, in Brass Local Government Area of the state from Government Henry Seriake Dickson in Government House, Yenagou on Wednesday.

A Government House press statement signed by the Chief Press Scoretary to the Bayelsa State Governor, Francis Ottah Agbo, noted that the Executive Vice Chairman, who highlighted the components of the Fertilizer plant, explained that, it would accommodate a Methanol. Usea Ammonia, Gas Processing Plants as well as a 35 kilometre Pipeline Project.

Describing the project as the single biggest private wotor company in Africa with a Hillion dellar equity fund. Chief Okoye canvassed the total support and cooperation of the Government towards the realization of the project and expressed optimism that, it would transform the state's economy and that of the country as a whole.

Chief Okoye said, "We are here today because we have achieved 95%, in terms of funding and equity for the project. You will agree with me that, raising 3.5 billion dollars in this clime is not an easy task. And, this is the first private sector investment in Africa that has attracted ibillion dollar enough Frond."

Speaking shortly after presenting the Certificate of Occupancy to the Company officials, Governor Serialse Dickson assured the management of the Brass Fertilizer Company Ltd of his administration's readiness to sustain the existing conducive operating environment for business investments to thrive in the state.

Covernor Dicloson, who amounced a 2 year tax holiday for the Company, explained that, the gesture was aimed at facilitating the early commencement of the much desired investment.

While communiting the Managament of the Company for its efforts, especially in the arm of funding, the Governor rejectood his call on the Federal Government, the Nigerian National Petroleum Corporation, NNPC and other investing partners to urgently bring the Brass Liquefied Natural Gas projection stream.

"To further encourage you, I've also directed a waiver of all fees for two years so that in the next one or two years, when the project must have started, you will then pay up all fees to the last kobo. We want you to put that money into the project and get it started," the Governor stressed.

African Development Bank Calls Off Proposed Loans to Nigeria

Bank has called off a loan to Nigeria that would have helped fund the country's budget, instead redirecting the money to specific projects, a vice president at the lender said on Monday. The African Development Bank had been in talks with Nigeria for around a year to release the second, \$400 million tranche of a \$1 billion loan to shore up its budget for 2017, as the government tried to reinvigorate its stagnant economy with heavy spending. But Nigeria refused to meet the terms of international lenders, which also included the World Bank, to enactvarious reforms, including allowing its currency, the naira, to float freely on the foreign exchange market. Nigeria's 2017 budget, 7.44 trillion naira, is just one in a series of record budgets that the government has faced obstacles funding, pushing it to seek loans from overseas.

In late 2016, the AfDB agreed to lend Nigeria a first tranche of \$600 million out of \$1 billion. But negotiations over economic reform later bogged down, blocking attempts to secure the second tranche of \$400 million, sources told Reuters then.

Now, AtDB's loans will be more targeted, Hott said.

"It's hundreds of millions of dollars, just in one go, that we were supposed to provide in budget support, but we will move into real projects..." he said.

Earlier this month, the head of Nigeria's Debt Management Office said the country is still in talks with the World Bank for a \$1.6 billion loan, which will help plug part of an expected \$7.5 billion deficit for 2017.

The administration is also trying to restructure its debt to move away from high-interest, naira-denominated loans and towards dollar loans, which carry lower rates.

Strategic Development Plan on Domestic Gas Export -NLNG MD

he Managing Director of Nigeria LNG Limited (NLNG), Tony Attab, at the recently concluded Nigerian Economic Summit in Abuja, said that a long-term strategic development plan would encourage investments, improve infrastructure in the country and boost production of both export and domestic

Chairing a breakout panel discussion at the Energy Session of the 23rd Nigerian. Economic Summit (NES) titled Exploring private sector opportunities and investment in gas," Attah remarked that the domestic gas export business could easily attract more investments which can be used to develop the muchneeded infrastructure to unlock and unleash the potentials of proven and unproven domestic gas reserves of 187 and 600 trillion cubic feet (tof) respectively in the country. He added that this can only be enabled via the right policies, legislation, and incentives to drive investments in the sector.

The session was attended by the Honourable Minister of State for Petroleum, Dr. The Kachilewe; the Group Managing Director of Nigerian National Petroleum Corporation (NNPC), Dr. Maikanti Baru as well as the President of the Nigerian Gas Association, Engineer Dada Thomas and other inclustry chief executives.

Commenting on the potential of domestic gas in Nigeria, Attah stressed that it was time for gas development in Nigeria, adding that the industry can stimulate growth in every sector of the economy especially agriculture, industries, and power, but it will only do so if factors currently inhibiting rapid growth are effectively addressed.

"Underinvestment in approisal and exploration activities due to moonsistent policies, unattractive commercial framework, security of investments, etc. invariably impact gas reserves, production, and commercialization".

Summarising short to long-term solutions reached by the panel, Attaly stated that the gas industry should be liberalized and a climate of the willing seller and willing buyer should drive gas price, rather than the current practice of price capping.

He also remarked further that Nigoria and Ostar started out in the gas business about the same time, however, Qatar has rapidly developed its gas industry and produces 77 million tomnes per annum (mtpa) of Liquefeed Natural Gas (LNG) while Nigeria's current capacity is just about 22 mtpa.

Barlier, while opening the session, Dr. Kachikwo said the Federal Government is looking at more gas investments as part of a strategic move from oil. He stated that the government is reviewing the existing Production Sharing Contract (PSC) gas terms as well as strengthening implementation of gas policies to encourage exploration of gas, adding that "gas infrastructure is a key area but policies will have to drive sariff possibilities."

NLNG Demands USD 315 Million Judgment Debt From NIMASA

he Management of Nigeria NIMASA in May 2013. LNG has formally issued a demand notice for the sum of USD \$315,598,823,29 judament debt to the Negerian Maritime Administration and Safety Agency (NIMASA). The sum protest to the Agency by NLNG since 2013, as well as direct and shipping losses incurred by NLNG due to the initial 2day blockade of the Bonny Channel by Bonny Channel for the purpose of enforcing

The development followed the decision on October 3, 2017, by the Federal High Court, Legos that NLNG was not liable to make the said payments to NIMASA, and that all such payments already made by represents the payments made under NLNG to NIMASA should be relanded forthwith, The Honourable Court Presided over by Justice M. B. Idris further held that NIMASA was wrong in blockading the

the payments against NLNG.

Commenting on the development, General Manager External Relations Dr. Kudo Bresia Ekesaid: The Federal High Court ruling transcends being simply a legal victory for NLNG. It must be viewed for what it really is: A resounding message from Nigeria to the global investment community. The message is that we can be trusted to keep our sovereign word and that Nigeria remains open for business partnership and investments."

NIMASA had alleged that NLNG was liable to pay three percent gross freight levy on its international inhound and outhound cargo, Sea-Protection Levy, two percent cabotage surcharge as well as other sundry claims, all of which NLNG disputed. NLNG, in 2013 filed the case at the Federal High Court against NIMASA, seeking a judicial determination on, among other things, the legality or otherwise of the levies sought to be imposed on NLNG by NIMASA, and the consequent blockack of the Bonny Channel by NIMASA and its agent as a result of the dispute.

NLNG had also sought a Court Order restraining NIMASA from further blockade of the Channel. An Interim Injunction granted in favor of NLNG by the Federal High Court was disobeyed by NIMASA, which again blockaded the Bonny Channel over a three week period while the matter was pending, thereby preventing NLNG vessels and other vessels doing business with the Company from entry and exit through the

NNPC/Agip JV to Increase Power Generation by 480mw

he Nigerian National Petroleum Corporation (NNPC) and the Nigerian Agip Oil Company (NAOC) Joint Venture is set to boost the Federal Government power generation aspiration by 480 megawatts (MW) through the completion of its Okpai Phase II Independent Power Project (IPP)

This was disclosed in Abuia on Thursday during the inauguration of the Okpai Phase II power project by the Group Managing Director of NNPC Dr. Maikanti Kacalla Baru.

Speaking at the event, Dr. Baru said all partners were working round the clock to deliver on the project in terms of specifications, time and

He said the decision by the partners to emback on the second phase of the Okpai power project was hinged on the enormous success of Okpai Phase I, which he described as the most consistent power plant in the country.

*Although it (Okpai Phase I) was meant to generate 450MW into national grid, it is now generating an average of 300MW due to evacuation. challenge. This is a significant addition to the national grid," he said.

He said the Okpoi Phase II project, on completion, would generate additional 480MW into the national grid.

Russia Signs Agreement With Nigeria for Nuclear Power Plant

ussia has signed agreements with Nigeria usage of nuclear technologies. Nigeria in 2015 to build and operate a nuclear power plant in the oil rich West African nation that has a deficit of reliable power and faces security challenges by Islamist militants in the far northeast.

Peasibility studies for the plant and a research center construction will include site screening, capacity, financing, and time frames of the projects, state-owned Russian nuclear company Rosatom said in an emailed statement. Representatives from the firm and the Nigeria Atomic Energy Commission signed the deal.

The nations in 2009 signed an intergovernmental agreement on cooperation in the field of the peaceful was in talks with Resatom to build as many as four nuclear power plants costing about \$20 billion, the Nigeria Atomic Energy Commission said at the time.

Nigeria, Africa's most populous nation. distributes an average of 4,500 megawatts of electricity. Half the output of the Egbin power plant, the nation's biggest, is lost because of inadequate transmission infrastructure, its chiefofficer said last month.

Rosatom is seeking to build nuclear power. plants in other countries on the continent including South Africa.

In the same vein Hameed Ali, comptroller-general of the Nigeria Customs Service (NCS), says the All Progressives Congress (APC) government "cannot move forward" because 50 percent of those in the current administration are from the Peoples Democratic Party (PDP).

Ali said this on recently while speaking at the official commissioning of the national headquarters of Buhari Support Organisations (BSO) in Abuja.

The customs CG said the Buhari administration ought not to have allowed PDP members to call the shots.

He said some of those who played major roles for the party to conte to power in 2015 had not been fully appreciated.

"Today, with all sense of responsibility, I want to say that we have 50 percent of PDP in our government. How can we move forward with this load? How can we achieve our target with this load? It is a spoilt system and so," he said.

"When you come in, you shake off everybody and bring in your own. That is what democracy is all about.

"Today, we have members of PDP calling the shots. That is what we will begin to fight for, we will fight for our right position, our vision and our mission for this government.

"I will, therefore, ask my colleagues of the BSO to go back to the

study room. This is a commission, but it is also the beginning of the fight for good governance. We must get back to the trenches, draw our own battle plan and battle line.

"I enjoin you that the same commitment we had in 2015, I employ you to bear with us and commit yourself to a better future for Nigeria. We will be calling on you from now on and we will be working day and night. "We must do so because we want to save our name and the name of the president for what he is doing."

All who had a face-off with the senate earlier in the year is not known for making political statements.

President Buhari who was also said to have held discussions with some Northern state governors at the Aso Rock Villa on Friday 27 October 2017 after the Friday Jumat Prayer was said to have told them of his plan to seek reelection in 2019.

Buhari is said to have won the 2015 Presidential election by mobilizing Muslim communities in the

country that the election against then incumbent President Goodluck Jonathan was a holy war. Many people especially from the North mobilized for him to win the election.

A former governor of Jigawa state Alhaji Sule Lamido confirmed this in a recent interview with newsmen shortly after the 2015 election that Buhari's supporters campaigned in the name of Islam and that those who do not support his candidacy were regarded as unbelievers.

No sooner than he was sworn in as President many started accusing his government of trying to Islamise the country. An allegations that he himself has not tried to deny, leaving the Vice President Professor Yemi Oshinbajo and the Sultan of Sokoto and even the Catholic Archbishop of Abuja John Cardinal Onaiyekan to do the denial.




The mayhem reportedly began when Lamido decided to address his supporters after inspecting his campaign office in Kaduna.

"We have been demonised because of our opinion. We will not succumb, because this is our country. We shall review Nigeria.


"Today, they have turned Nigeria

Osinbajo condemns criticisms against Sukuk Bond, says nobody will Islamise Nigeria

ice President, Prof. Yemi Osinbajo, said that it was impossible for anyone to Islamise country's membership of the Nigeria, as claimed by Christian interests. He also noted that many people look for - Islamic Development Bank. Islamic agenda everywhere as if they were looking for demons

The Punch reports that Osinbajo, who was speaking in Lagos on Friday, October 27 during the Nigeria, many nations of the Greater Nigeria Pastors Conference convened by Apostle Wale Adefarasin and Rev. Abayomi Kasali, explained that the recent uproar over the country's subscription to Sukuk Bonds was not justified.

Osinbajo said: "Part of the problem is the failure of Christian leadership to take its rightful place. We focus our minds on samething we call the Islamic agenda. We look for it everywhere at if we are looking for demons.

But tabere is the Christian agenda. Are we not entitled to one? We are too divided as Christians to have an agenda. The key to the unity and progress of Nilgeria is in the church."

According to him, there were no plans to Islamise Nigeria through the Sukuk bond or the

He said that apart from world including the United States of America and the United Kingdom had also embraced the system as a result of its progressive nature.

He said: "The Sukuk is an Islamic concept, which enables people to have access to credit. It is essentially like a bond. The

US, UK, China, South Africa have all used the Sukuk. Once there is money in the market, let us not get sentimental. The most important thing is for us to use those monies well.

Some people say there are some bidden things in this arrangement and that one day somebody is going to take us over. Where? How will that happen? These are straightforward financial systems used all over the world. I don't think it presents any real problem. It is a very progressive financial system.

"Nigeria became a member of the Islamic Development Bank in 2005 and the first person to sit as director of the bank was Ngozi Okonjo-haesla. The second person to sit as a director is the current finance minister, Kemi Adension, and both of them are Christians. So, when people talk about Islamic agenda, sometimes Lam lost.

"The person who brought us into the bank is not a Fulani or northerner, the person was a Christian, so why are we complaining? Nigeria is the fourth largest shareholder in the Islamic Bank. This wasn't Buhari's making. We must have facts before saying things. But above all, we must ask ourselves if being a member of the bank profits as or not.

"For me, I have no problem with this. We can use what we get there to develop our society. This is the most important for me."

Osinbajo also spoke on the case of a former Chairman of the Presidential Task Force on Pension Reforms, Abdulrasheed Maina, who was discovered to have been reinstated in the Federal Civil Service, after he had earlier fled the country in 2013 after corruption charges were brought against him by the Economic and Financial Crimes Commission.

The vice president said the country's system made it possible for criminals to go undetected.

He said: "If you look at our present federal structure, it is designed in such a way that you may be able to hide somewhere for a day or two before you are found. Otherwise, how do you explain a rituation where a fugitive ruddenly appears and finds his way back into the systems? How did be get there?

"What Bubart did immediately be heard about the matter was to query

how it happened and ordered his disengagement, which is the right thing to do. As for subat will happen, we may have to wait and see."

Osinbajo accused the country's elite of working against the progress of the country.

While calling on citizens to support the current administration in its fight against corruption, the vice president said that Nigeria was at the threshold of history and would soon fulfil its full potential.

He said: "We must deal with corruption decisively. It is created by leadership elite that include: not just politicians but also religious leaders and people in the private sector. We must also deal with tribulism, religion and other purochial tendencies. It is difficult to find national leaders today. Many Nigerians speak from a tribal perspective.

"There is no nation on the face of the earth that would survive under the weight of corruption that our country had gone through. Nigeria's clite, regardless of political, religious or ethnic differences, think alike. They are driven largely by the same motive.

"They are selfish, unprepared to make the sacrifices either in service or self-restraint that leaders of successive societies make. High-level corruption knows no religion, ethnicity or other considerations.

Corrupt elements in our society are united; they fight for each other and are prepared to go down together. They are actually one cribe, indivisible despite their diversity.

"We base to address the issue of corruption pointedly. The system is corrupt. Corruption is generally the rule in our society. This is a time to build. We can become Africa's most productive nation in the very near future."

Commissioner, Cross River State Ministry of Works, Housing and Transport, Christian and citizen of the Federal Republic of Nigeria now residing at Obi Odu Estate, No.4 Basin Road, Abakpa, Ogoja and a native of Adagom, Odajie- Mbube in Ogoja Local Government Area Cross River State.
- I contested the House of Representatives Election under the platform of Labour Party during the recently concluded 2015 general elections and further lodged a petition before the National and State House of Assembly Election Tribunal holden in Calabar on the 17th April 2015. The petition was however, dismissed on technical grounds on the 5" of August 2015.
- I went further to the Appeal Court to seek redress but the appeal was again dismissed by the Appeal Tribunal holden in Calabar on the 29" of September, 2015.
- However, it then come to my notice that the Election Tribunal (Panel One) that dealt with my matter was not properly constituted according to law as regards qualification of the Chairman who is a Judge of the Customary Court of Appeal from Taraba State which negates the sixth schedule of the 1999 Constitution as amended that expressly provides: The Chairman Shall be a Judge of the High Court.
- Consequently, all proceedings from the

- National and State Assembly Election Petition Tribunal Chaired by Justice C. Awubra sitting as (Panel One) which dismissed my petition on technical grounds are a nullity and so are the Appeal Tribunal decision also a nullity. See Annexure A being judgment by the Tribunal (Panel One) disqualifying themselves.
- On the 6" Oct 2015 I wrote a letter to the President of the Court of Appeal and raised the above issues in order that necessary action be taken to cause my matter to be heard by a competent court, see Annexures B and C the response from the President of the Court of Appeal which was dated 12th Oct 2015 and I have since then been very traumatized because of the way and manner the President of the Court of Appeal has used the office as President of the Appeal Court to inflict damage to my fundamental human right and also for laying the foundation for depriving me and mischievously ensuring that my above matter was not heard before any competent court or Tribunal. deny me any opportunity for fair hearing.
- As it stands, no Tribunal was set up to hear and determine my election petition in Cross River State consequently the disqualification of the Chairman of the Tribunal who is a Judge of a Customary Court of Appeal in Taraba State of Nigeria and not a Judge of the High Court as required by the Constitution.
- The President of the Court of Appeal

cannot claim ignorance of the above and yet wrote Annexure B even when I raised the issue of the disqualification of the Chairman of the Election Tribunal and the Hon President of the Court of Appeal still had ample time to setup a Tribunal to properly handle my Election Petition Matter as required by law but to no avail.

I contended that the position the President of the Court of Appeal took was offensive to the tenets of constitutional democracy, rule of law and my well-being not given a thought to my rights as a human being who is entitled for justice and fair hearing.

The President of the Court of Appeal exhibited acts that were very unjust; never conveyed certainty for justice and as the guardian of the rule of law up to the Appeal Court, was also not only Undemocratic, anti-judicial; very mischievous and most tyrannical. This act led to the rape of my fundamental human rights as no remedy has been provided up till-date to enable me as a Petitioner who through no fault of mine filed my petition timorously to ventilate my grievances but have been deliberately denied and shut out of justice and the forum provided by the Constitution of the Federal Republic of Nigeria to ventilate my grievances and get the consequent judicial remedy.

From all indications I stand to be corrected, The President of the Court of Appeal deliberately perpetrated illegality with those Tribunal Panel One Hon. Judges in collaboration. It is shocking that the President of the Court of Appeal would indulge in illegalities in his administrative duties.

It is pertinent to state that the Cross River State (Panel One) of the National and States Houses of Assembly Tribunal which had a very high number of Petitions that stood at twenty-five Petitions; Petitioners suffered the Biggest Judicial rape on Judicial processes that denied Cross Riverians and those who contested elections where never given the opportunity to ventilate their grievances and I have no doubts that these actions by the President of the Court of Appeal can lead to acrimony and anarchy if not properly handled.

In fact these groups of Justices held all of us the Litigants under Election Tribunal (Panel One) to ransom. My Lord I humbly appeal that we must never again allow any group to hold the Nation; particularly Cross River State to ransom under whatever guise.

Basking on the change slogan which is not a campaign gimmick a promise by President Muhammadu Buhari that must be kept. I humbly wrote on the 12" Jan 2016 to then Chief justice of Nigeria and Chairman of the NJC and requested that the above matter be thoroughly investigated. It is on the above bases I felt the Chief Justice of Nigeria and Chairman of the NJC would have had enough time to investigate my petition as contained in Annexure A. and respond to my appeal but unfortunately up till date they has been no response the reason for this letter.

Furthermore the vexed issue of corruption amongst judicial officers once again took the center-stage at a thanksgiving service organized for My Lordship The Chief Justice of Nigeria at the Methodist Church, Nigeria, and Abuja Diocese. The occasion afforded My Lordship an opportunity to bare his mind on this matter that is questioning the integrity of the judiciary in the country.

To check the problem, My Lord The Chief Justice of Nigeria advised Nigerians to petition the National Judicial Council (NJC) on the corruption and other unprofessional conduct of judges. My Lordship also advised the people to take advantage of relevant institutions and report all allegations of corrupt practices against judges, instead of smearing the image of the judiciary with unsubstantiated allegations in the mass media.

In retrospective because I never wanted my matter to be a media affair; then the seemingly cover up with no response or even an acknowledgement.

The matter no doubt is a high wired conspiracy and rascality of the first order on the part of the President of the Court of Appeal and the three Judges of the Election Tribunal (Panel One) who are Hon. Justice O. A Adenivi; Hon. Justice C. D. Awubra and Hon Justice J. U. Oyomirewho sat and master minded the rape and assassination of my Petition in Cross River State to favour the PDP Candidate.

It is unfathomable that the President of the Court of Appeal has decided to return the country to anarchy in a rather brazen and bizarre manner. It is not a case of oversight or lack of knowledge of the

President of the Court of Appeal or on the part of the Tribunal Judges who no doubt knew that their composition from day one was unconstitutional; but a mischievous, deliberate and judicial rascality to turn back the hand of the clock in the ongoing battle against impunity and trying erase the maxim that Democracy which is based on due process is being basterdard by Judicial Officers who have made up their minds to be unethically minded.

The President of the Court of Appeal and the three Judges of the Tribunal have succeeded in denving the fundamental rights of the Cross Riverians through authoritarianism and rascality. They have denied me and my constituents the right to vote and be voted; as earlier stated these actions brazenly manipulated against the wish of my people.

The President of the Court of 22. Appeal and the three Judges of the Tribunal failed to play their role as impartial and neutral arbiter and no doubt allowed PDP in Cross River State to use them as pawns in their quest for power and thus defiled the constitution and the law of the land in a manner that demands concrete action; investigation and equally meet my humble demand.

23. During this period of waiting and demanding for justice I have been very traumatized because of the way and manner the President of the Court of Appeal has used the office as President of the Appeal Court to inflict damage to my fundamental human right and also for laying the foundation for the very many misfortunes that equally affected my business and have since left me unfocused and my health condition further deteororated.

The high wired conspiracy by 24. the President of the Court of Appeal and the Tribunal Judges is still shaking the fabrics of our Constitution; CrossRiverians and my humble self are still and remain in shock.

I am compelled at this juncture to raise this matter in view of the fact that they has been no response to my letter dated 6" Oct 2015 where I raised many issues which no doubt would be attended to this time as I cannot continue to wait in vain . In the light of the foregoing I do hereby call on The National Judicial Commission our highly esteemed Institution to use its good offices to look into the matter to forestall any future occurrence. Am aware of the stand of the NJC to take the Judiciary to its enviable height, I urge The NJC to act accordingly with a view to bring an end to this issue raised above.



Sack indicted government officials - APC chieftains tell President Buhari

ome chieftains of the All Progressives Congress (APC) have said the integrity of President Muhammadu Buhari is now in doubt following his failure to sack indicted government officials in his administration.

Speaking in separate interviews with the Punch, the chieftains called on the president to sack the suspended secretary to the government of the federation Babachir Lawal, the suspended executive secretary of the national health insurance scheme, Usman Yusuf, and the suspended director-general of the national intelligence agency, Ayo Oke, to save his anti-graft war.

One of the chieftains in Adamawa state, Mark Wosi, said from all indications. Buhari was foot-dragging on the issues because the men involved were his lovalists.

"You can't keep telling us you are fighting corruption while there are corruption allegations against people around you and yet you can't do anything about it.

This only means you are the father of corruption. The integrity of President Muhammadu Buhari is now in doubt with all these fraud cases under his nose," he

Another top party member who serves as the chairman, House of Representatives committee on justice, Razaq Atunwa, called on the president to sack and prosecute the affected government officials.

He said: "If someone has committed a financial crime or fraud, he must not only be dismissed from office but be made to face the music. It is for the court to decide if the person is guilty of that offence or not."

An APC chieftain in Ogun state, Chief Bode Mustapha, said he would expect the president sack the officials involved if they were indicted by the reports.

56 YEARS OF FIGHTING CORRUPTION IN NIGERIA

he most talked about any topic in Nigeria today is corruption. It has become the most talked about topic because in Nigeria the best way to wage any war against your enemy is to accuse him or her of corruption. In every election in the country the first manifesto to get the support of the public is to talk about corruption and tell the nation how you intend to fight the scourge. Nigerians have the mindset that all public officers are corrupt, they only need someone to declare it and there might be a mob action. Incidentally too, corruption in Nigeria has tribal, Religious, Regional and Partisan coloration. An activity amount corruption only if our opinion leaders say it is corruption otherwise it amount to persecution.

As a patriotic Nigeria I have decided to once again discuss the issue of corruption in the country as the current administration of President Muhammadu Buhari and the All Progressives Congress [APC] have been celebrating their war on corruption and want Nigerians to celebrate the war with them even when it has not transformed their lives or put food on their table.

Difference people across the country have given their own opinion on what should be done to corrupt officials. Some have said corrupt officials should be executed, some even said corrupt officials From Vincent Egwanvenga

should be banned for life from holding any public office. But to the APC and the government their fight against corruption is meant to discredit the immediate past Administration of Goodluck Jonathan and use it to kill the PDP permanently.

Am not going to join issues with these arguments but to remind Nigerians that there was a time in this country when armed robbers were executed. We called it the bar beach show then. They were executed in bar beach in Lagos. But it did not end armed robbery in the country.

I will only give a literature review of the fight against corruption in Nigeria since 1960 and allow Nigerians to judge.

Chambers Twentieth Century Dictionay defines corruption to mean, to make the purity, to taint, to debase, to spoil, to destroy the purity of, to pervert, to bribe, from the above definition Corruption is not just about stealing money, corruption includes rigging of an election, cheating during examinations, Nepotism, Match fixing etc.But in Nigeria corruption simply means stealing public funds, and the only person that can find you quilty of corruption is not the courts or the Judiciary but the leadership of political parties other than your own. Corruption allegations and wars have been on in Nigeria as far back as Independence in 1960. Every successful


accused the other of corruption. One of the reasons why the first military coupists struck was because they accused the politicians of the first Republic of corruption. Corruption, though

government always

prevalent, was kept at manageable levels during the First Republic. However, the cases of corruption during the period were sometimes clouded by political infighting.

Azikiwe was the first major political figure investigated for questionable practices. In 1944, a firm belonging to Azikiwe and family bought a Bank in Lagos. The bank was procured to strengthen local control of the financial industry. Albeit, a report about transactions carried out by the bank showed though Azikiwe had resigned as chairman of the bank, the current chairman was an agent of his. The report wrote that most of the paid-up capital of the African Continental Bank were from the Eastern Regional Financial Corporation.

In western Nigeria, pulitician Adegoke Adelabu was investigated following charges of political corruption leveled against him by the

opposition. The report led to demand for his resignation as district council head.

In the Northern region, against the backdrop of corruption allegations leveled against some native authority officials in Bornu. The Northern Government enacted the Customary Presents order to forestall any further breach of regulations. Later on, it was the British administration that was accused of corrupt practices in the results of elections which enthroned a Fulani political leadership in Kano, reports later linking the British authorities to electoral irregularities were discovered.

The immediate reasons for the firstcoup, however, concerned the nationwide disillusionment with the corrupt and selfish politicians, as well as with their inability to maintain law and order and guarantee the safety of lives and property. During the initial stages. Nzeogwa and his collaborators were hailed as national heroes. But the pattern of killings in the coup gave it a partisan appearance: killed were the prime minister, a northerner, the premier of the Northern Region, and the highest-ranking northern army officers; only one Igbo officer lost his life. Also killed was the premier of the Western Region who was closely allied with the NPC.

Corruption for the most part of Yakubu Gowon's administration was kept away from public view until 1975. However, informed officials voiced concerns. Critics said Gowon's governors acted like lords overseeing their personal fieldom. He was viewed as timid, faced with corrupt elements in his government.

In 1975, a corruption scandal surrounding the importation of cement engulfed many officials of the defense ministry and the central bank of Nigeria. Officials were later accused of falsifying ships manifestos and inflating the amount of cement to be purchased.

During the Gowon administration, two individuals from the middle belt of the country were accused of corruption. The Nigerian government

controlled the newspapers, the Daily Times and the New Nigerian gave great publicity to denunciations of the administration of Gomwalk, and Federal Commissioner Joseph Tarka by the two critics. A situation which may signal a cause for exigent action on corruption.

On July 30, 1975, Brigadier (later General) Muhammed was made head of state, when General Gowon was overthrown while at an Organization of African Unity (OAU) summit in Kampala, Uganda, Brigadiers Obasanjo (later Lt. General) and Danjuma (later Lt. General) were appointed as Chief of Staff, Supreme HQ and Chief of Army Staff, respectively. In the coup d'état that brought him to power he introduced the phrases 'Fellow Nigerians" and "with immediate effect" to the national lexicon. In a short time, Murtala Muhammed's policies won him broad popular support, and his decisiveness elevated him to the status of a folk hero.

One of his first acts was to scrap the 1973 census, which was weighted in favor of the north, and to revert to the 1963 count for official purposes. Murtala Muhammad removed top federal and state officials to break links with the Gowon regime and to restore public confidence in the federal government. More than 10,000 public officials and employees were dismissed without benefits, on account of age, health, incompetence, or malpractice. The purge affected the civil service, judiciary, police and armed forces, diplomatic service, public corporations, and universities. Some officials were brought to trial on charges of corruption. He also began the demobilization of 100,000 troops from the swollen ranks of the armed forces.

During Olusegun Obasanjo first military administration there were allegations of corruption against his Administration. The most talked about at that time was the alleged missing of \$2.8billion missing oil money, an enquiry was set up. At the end of the day a reporter with the Nigeria Television Dora Ifudu was sacked for having the audicity to air the news a on a National Television.

The first administration of Olusegun Obasanjo was a continuation of the Muritala Mohammed administration, and was focused on completing the transition program to democracy, as well as implementing the national development plans. Major projects including building new refineries, pipelines, expanding the national shipping and airlines as well as hosting FESTAC was done during the administration. A number of these national projects were conduits to distribute favors and enrich connected politicians. The famous Afrobeat musician, Fela Kuti, sang variously about major scandals involving the international telecommunication firm ITT led by Chief MKO Abiola in Nigeria, which the then Head of State, Gen Olusegun Obasanio was associated with. In addition to this, the Operation Feed the Nation Program, and the associated land grab under the Land Use Decree implemented by the then Head of State was used as conduits to reward cronies, and his now famous Otta Farm Nigeria (OFN) or Operation Fool the Nation [OFN] was supposedly a project borne out of this scandal.

Olusegun Obasanjo handed over the mantle of leadership to Alhaji Shehu Shagari in 1979. This was regarded as the second Republic in the country. There were so many allegations of corruption during the Republic, there were allegations of rice scandal etc.

In December 1983 there was a bloodless Military coupled by the then General Muhammadu Buhari, General Buhari arrested almost all the Politicians that held public office. This included Ministers, Governors etc. even the Military was not left out as two senior military officers who headed the National Youth Service Corps [NYSC] were dismissed and sent to life imprisonment. Special Military Tribunals were set up to try the politicians and they were all found guilty and sent to various prison sentences from twenty five years to life imprisonment. There were however doubts as to the integrity of the War on corruption and Indiscipline which was launched in 1984.. Former governor of old Bendel state Professor Ambrose Ali, a Professor of Morbid Anatomy was sentenced to life imprisonment for stealing an amount that was less than one million Naira. At the time the man died later it was discovered that he had no personal house any where in the world, in fact the military administrator of Bendel state at that time had to build a house for him in Ekporna where he was buried. The governor was so moved that he had to name the state University, Ambrose Ali University. This was someone that was sent to life imprisonment for corruption. That was not all, even the Buhari Administration then had its own scandal as the administration could not explain how 53 suit cases entered the country during the currency exchanges.

Buhari himself was overthrown by General Ibrahim General Bahangida in a palace coup in 1985. Bahangida did not make any noise about fighting corruption but concentrated on policies to help the poor. These include the Peoples Bank, Directorate of Food, Road Infrastructure and MAMSER. He set up different Political Reforms programmes, created two Political Parties, the National Republican Convention [NRC] and the Social Democratic Party [SDP]. THIS he said was to prevent the rich from hijacking the Political system. He also created the Structural Adjustment Programme [SAP], HIS Administration was also accused of corruption especially the alleged swindling of \$12b dollars oil windfall. The biggest attempt to discredit anti-corruption crusade in the country took place under this administration. There was an allegation in 1992 that the then first lady Maryam Babangida opened the biggest boutique in France and that it was published in the Ebony Magazine. There was a massive protest in the country especially in Lagos, organized by some Civil Society Organisations and students under the aegis of National Association of Nigeria Students, It was later discovered that the allegations was untrue and that Ebony Magazine never published any such story.

After Babangida came the Interim National Government headed by Chief Sonekan. Then General Sani Abacha swept Shonekan aside and took over power in 1993. Abacha came and said he wanted to fight corruption and to give credibility to his administration he invited General-Muhammadu Buhari to be part of his government and made him the Chairman Petroleum 'Trust Fund [PTF]. As part of his anti corruption fight, Abacha established the Money Laundering Law in 1995, established the Failed Bank Tribunal in 1995 and the Foreign Exchange Law also in 1995. As part of his anti-corruption fight many banks, mortgaged and finance houses collapsed. Despite all these anti corruption fight, Abacha regime is reputed to be one of the most corrupt regime in the country. The Swiss bank has continued to return some of the money stolen from Nigeria by Abacha and members of his family.

The death of the general Sani Abacha revealed the global nature of graft.

French investigations of bribes paid to government officials to ease the award of a gasplant construction in Nigeria revealed the level of official graft in the country. The investigations led to the freezing of accounts containing about \$100 million United States

In 2000, two years after his death, a Swiss banking commission report indicted Swiss banks for failing to follow compliance process when they allowed Abacha's family and friends of access to his accounts and to deposit amounts totaling \$600 million US dollars into them. The same year, a total of more than \$1 billion US dollars were found in various accounts throughout Europe.


After Abacha regime came General Abdulsalami Abubakar whose interest was mainly to hand over power to civilian administration.

Abdusalami administration was succeeded by Chief Olusegun Obasanjo of the Peoples Democratic Party [PDP]. OBASANJO also said he was to fight corruption. He said 'As torch bearers the elite must lead by examples and their conducts and character in both private and public service must reflect that spirit of total and undiluted opposition to corruption and any criminal conduct'.

As part of his anti-corruption fight Chief Obasanjo set up the Economic and Financial Crime commission [EFCC], Independent Corrupt Practices Commission [ICPC]. DUE PROCESS

OFFICE, SERVICOM etc. the EFCC under Ohasanjo was headed by a retired commissioner of Police Nuhu Ribadu. Nuhu Ribadu who became very popular in the country for daring to harass and intimidate political office holders including Governors and two former Inspector General of Police. By the time Obasanjo ended his tenure Nuhu Rihadu report revealed that all the incumbent governors at that time between 1999 and 2007 were guilty of corruption. Some of the governors then are now godfathers, kingmakers and party leaders. There were however allegations of political intimidation as opposition political parties and the opposition within the ruling Peoples Democratic Party [PDP] accused the administration of shielding the President's men of allegations of corruption. An example of course was one Makanjuola a former Permanent Secretary Ministry of Defence who was accused of stealing four hundred million Naira, President Obasanjo ordered the Ministry of Justice to enter a Nolle Prosecue and the charges were withdrawn. At the end of Obasanjo regime there were also allegations of corruption against him, despite his perceived war against corruption, these include PTDF, SIEMENS, ALLIBURTON scandal among others.

In a lecture delivered by Professor Taoheed Adedoja at the Oyo state House of Chiefs in 2006 to commemorate the 46th Independent Anniversary of Nigeria problems associated with corruption include

- loss of Revenue to government, for instance before EFCC, it is officially confirmed by Shell-Oil Company that in 2004 over 100,000 barrels of crude oil was stolen daily.
 - Poor investment climate
 - 3 Unemployment and low National productivity
 - Erratic services by state institutions
 - Lawlessness and disorder 5
 - Brain Drain.
 - Negative National image
 - Poverty engendered principally by mediocre people that access and lead government institutions through corruption.

Under Jonathan Administration In 2014, Nigeria's rank improved from 143rd to the 136th position on Transparency International's Corruption Perceptions Index. In late 2013, Nigeria's then central bank governor Sanusi Lamido Sanusi informed President Goodlock Jonathan that the state oil company, NNPC, had failed to remit US\$20 billion in oil revenues owed to the state. Jonathan however dismissed the claim and replaced Sanusi for his mismanagement of the central bank's budget. A Senate committee also found Sanusi's account to be lacking in substance. After the conclusion of the NNPC's account audit, it was announced in January 2015 that NNPC's non-remitted revenue is actually US\$1.48 billion, which it needs to refund to the government. Upon release of both the PwC and Deloitte report by the government at the eve of its exit, it was however determined that truly close to \$20 billion was indeed missing or misappropriated or spent without appropriation.

In addition to these, the government of Goodluck Jonathan had several running scandals including the BMW purchase by his Aviation Minister, \$250 million plus security contracts to militants in the Niger Delta, massive corruption and kickbacks in the Ministry of Petroleum, the Malibu Oil International scandal, and several scandals involving the Petroleum Ministry including accusations of sweetheart deals with select fronts and business people to divert public wealth. In the dying days of Goodluck Jonathan's administration, the Central Bank scandal of cash tripping of mutilated notes also broke out, where it was revealed that in a four-day period, 8 billion naira was stolen directly by low-level workers in the CBN. This revelation excluded a crime that is suspected to have gone on for years and went undetected until revealed by whistle-blower. The Central Bank claim the heist undermined its monetary policy. In 2014, UNODC began an initiative to help combat corruption in Nigeria.

New allegations of corruption have begun to emerge since the departure of President Jonathan on May 29, 2015, including:

- \$2.2 billion illegally withdrawn from Excess Crude Oil Accounts, of which \$1 billion supposedly approved by President Jonathan to fund his reelection campaign without the knowledge of the National Economic Council made up of state governors and the president and vice president.
 - NEITI discovered \$11.6 billion was missing from Nigeria LNG Company dividend payments.
 - 60 million barrels of oil valued at \$13.7 billion was stolen. under the watch of the national oil company, Nigerian National Petroleum Corporation, from 2009 to
 - NEITI indicates losses due to crude swaps due to subsidy and domestic crude allocation from 2005 to 2012 indicated that \$11.63 billion had been paid to the NNPC but that "there is no evidence of the money being remitted to the federation account*.
 - Diversion of 60% of \$1 billion foreign loans obtained from the Chinese by the Ministry of Finance
 - Massive scam in weapons and defense procurements, and misuse of 3 trillion naira defense budget since 2011 under the guise of fighting Boko Haram
- 7. Diversion of \$2.2 million vaccination medicine fund, by Ministry of Health
 - 8. Diversion of Ebola fight fund up

to 1.9 bn naira

- 9. NIMASA fraud under investigation by EFCC, inclusive of accusation of funding PDP and buying a small piece of land for 13 billion naira
- 10. Ministry of Finance led by Okonjo Iweala hurried payment of \$2.2 million to health ministry contractor in disputed invoices
- 11. NDDC scams and multifarious scams including 2.7 billion maira worth of contracts that does not confirm to the Public Procurement Act
- 12. Police Service Commission Scam investigated by ICPC that revealed misappropriation of over 150 million naira related to election related trainings, ICPC made refund recommendations, but many analyst indicated prosecution was more appropriate.

President Muhammadu Buhari has said he is committed to fighting corruption in the country, he said he want to prove to Nigerians and indeed the world that the country can be governed with Integrity, Nigerians may have to wait till the end of the administration to be able to know if it had also been guilty of corruption or not but Nigerians are also quick to remind the administration that Nepotism and election rigging is also corruption.

Probably corruption may never end in the country not even one hundred Buharis' as the country itself was structured on corruption. The Federal Government is too big, too powerful, too influential. Any body who get government appointments see it as an opportunity to get rich too. We probably have to restructure the country to make it work. Let us adopt fiscal Federalism where every region or zone or states should take ownership of their resources and pay tax to the Federal Government. There will be competition and every region or state will compete to develop its own area based on their comparative advantage. Those who want to use their resources to build schools and give its people free education can go ahead and do so while those who want to use their resources. to build places of worship should also be allowed to do so but no part of the country should be held back from its developmental programmes for other parts of the country to catch up later.

and Okhoromi are cases in point where several efforts to settle the



Ogieayevbona Igbinenikao whose leadership of the Village was been contested as the traditional ruler of the Village as well as the Ohen of Azagba, High Priest Nosakhare Ogieriakhi who was confirmed as the traditional head of Azagba Village as well as the confirmation of Ohen Okun N'Ovun as the head of Iguelaba village in Orhionmwon Local Government Area. through the patched Sahara Desert has become the order of the day in recent times. and stakeholders have now fired warning to Nigerian youths against the growing trend.

There is a recent photograph believed to be that of migrants hounded in an inflated boat as they were trying to cross the Mediterranean Sea.

The picture is trending on social media alongside that of several bodies floating on the water and believed to be those of migrants who perished at sea after their boat had capsized.

The latter brings straight home the flipside of the desperation for illegal migration to Europe through the African land borders and the Mediterranean Sea.

Indeed, an overland journey to Europe via the patched Sahara Desert can

be one deadly adventure. Yet, all that is being said about this trip, according to some observers, seems to fall on deaf ears, with many youths ever willing to defy the voice of reason.

First, they slip into Niger Republic. Then they make their way through Mali to Libya or Morocco. daring to cross the big, blue and bullish Mediterranean Sea to enter Italy or Spain.

Experts say that the migrants are usually driven by certain push factors, chiefly the barsh economic challenges buffeting most parts of the continent. They want to go to Europe where the streets are reportedly made of gold, So. with the very little money they lay their hands on, they hit the roads and refuse to count the cost.

But that is only where the story begins. Those who know the road through the desert to North Africa say that it is not the average one. Chances of survival on it are slim. The adventurers must fight the sand, the searing heat and stinging cold, the marauding Tuaregs bandits, hunger and thirst at their peals. The lucky ones

who manage to reach any of the Maghreb countries do so with lots of bruises.

When the migrants eventually reach North Africa, another phase of troubles begins. If they are lucky, they hike a ride, hounded into one dingy collapsible boat sailing for Europe, Such boats have clear potential of sinking at every approach of the least strand of misfortune needless to say that thousands drown every month. They are wholly at the mercy of the elements and the angry sea waves which lash at them without mercy as they rock along, enduring hours of numbness while praying to avoid vicious guards parading the waters for irritant migrants determined to reach Europe.

As the tale of Nigerian migrants streaming to Europe through the land borders continue to turn sour, some stakeholders over time have been doing their level best to stem the tide of this exodus. Recently, for instance, an initiative was launched to spread more awareness on the dangers inherent in this suicidal journey.

The progenitors called the initiative Migration Enlightenment Project in Nigeria (MEPN), with the support of the German Information office. At its launch in Lagos, one of its directors, Femi Awoniyi, said: "The initiative seeks to raise fresh awareness about the dangers and risks of irregular migration to

Europe and explain the legal requirement for regular migration with the overall objective of promoting safe migration.

"Most people who travel to Europe end up as irregular migrants. One boy wrote me from Spain complaining how he was imprisoned because be was accused of crimes he did not commit, all because be was an irregular migrant who didn't have arty papers.

Every now and then, we receive news of African migrants who died at sea while trying to cross to Europe to seek opportunities. The number is beartrending.

"Last year alone about 2,500 of such migrants who entered Europe were repatriated. This number is scary enough, but might be higher because Europe will not give us the right figures. We are sich of bearing of these calamities.

"The matter gets worse when we hear that parents close their businesses to finance their children's irregular migration. That is why the objective of this initiative is to increase public awareness on how to migrate to Europe legally. We want to make it clear that it is easy to get visas and there are other opportunities which Nigerians should know."

He regretted that some migrants were enticed with non-existent job offers, warning that it was better that people knew about the dangers involved in their actions before taking a leap. In his words, according to reports, 21,461 Nigerians were refused asylum in 2016 alone while 12,000 in Germany were awaiting repatriation.

*Unfurtimately, these who fail to get their stay don't wish to return home. They take to crime and prostitution.

While at the forum, Sadiat Hassan, a Deputy Comptroller of Immigration, who worked at Nigerian Embassy in Germany for five and half years, painted a sorry picture of the plight of Nigerians who migrated to Germany illegally.

"While I was in Germany, part of my Joh was issuing passports to Nigerians and visas to vintors.

But I didn't enjoy supervising the deportation of Nigerian illegal migrants. Then, I used to take a lot of painkillers because of some of the pathetic cases I used to encounter. As a mother, most times I wept when German officials invited me to come and see what some of our youths were pussing through.

If you are living there without permit, that is illegal. One of the options is for you to marry their citizens. Because of this, some of our youths kept going from one woman to another. Often, they went into

trouble; the girls among them were regularly suped. For God's sake, these were youths whose parents were here in this COMPLETY.

T'm not a lawyer, so I couldn't defend them. But I saw the Germans coming out to defend their own.

"To be honest with you, so many Nigerians are in prison there. But I couldn't belp them. Some would tell me: 'Ma, I'm tired; I want to go home; I'm married with kids!' Each time I heard that, my heart always broke. That was bow I started buying tickets for as many of them as I cannot now remember.

"Some couldn't even go home because of shame. They told me they sold everything they had to travel to Germany. And when they arrived, the story changed.

"Each time I visited the prisons, I felt sad. Lalways exept like a baby seeing lots of Nigerians and listening to their tales of suffering. Then, I concluded that it was not about going to Germany or any other European country that mattered.

"When they got shere the story abways changed, Germany, I know, no longer gives arylum to arryone. They have closed that policy a long time ago. So over youths need to go there now with dignity so that when they are returning, their dignity will remain intact

"There was a Nigerian Ludy subo was a prostitute. She was arrested 36 times by the German police. Each time I asked ber to 20 borne, she would say to me: 'Madam make I worksmall. '*

Former 'Mr Nigeria,' Deji Bakare, who was the compere on the occasion, recalled how he narrowly escaped going to Europe across the borders at the very last minute.

He said: "Fifteen years ago, some of my friends persuaded me to join them on their overland journey to Europe. I had prepared to travel with them; I had bought new clothes: I had N10, 000 on me.

But when I met them at Ojuelegha, Lagos, I changed my mind; I gave them my new clothes and left.

"Out of the monber that embarked on that trip, it was only one that came back alive. Two died at sea, others perished in the desert.

"But here I am today. I have soon the 'Mr Nigeria' contest once; I'm doing a abole for of shings with my life. What that means is that there are a lot of opportunities bere in the country, "he said.

Threats of new hostility in the Niger Delta signals failure of Osinbajo shuttle diplomacy



to the international oil companies working in the Niger Delta region of Nigeria, a militant cease-fire is officially over, the Niger Delta Avengers said.

*Our next line of operation will not be like the 2016 campaign which we operated successfully without any casualties," spokesman Murdoch Agbinibo said in a statement. "This outing will be brutish, brutal and bloody."

It's been nearly a year to the day since the group took credit for an attack on oil infrastructure in the Niger Delta region. The last time it took credit for an attack of note was during the second week of November 2016 when it said its rebel forces attacked an export pipeline controlled in part by a regional subsidiary of Royal Dutch Shell that has the capacity to carry as much as 300,000 barrels of oil per day.

The NDA accused the government of Nigerian President Muhammadu Buhari of lavoring oil and gas interests over the interests of the people in the Niger Delta and its campaign had been blamed for pushing total Nigerian crude oil production to a 30-year low last year.

This time, the NDA said it would target a floating production and storage facility under construction at a South Korean shippard, to be operated by the Nigerian subsidiary of French supermajor Total.

'We are presently tracking and monitoring its movement,' Agbinido said. 'And God

willing, it shall not operate successfully in amidst the return of the fury of the Niger Delta Avengers."

Total offered no comment when asked

After slipping into a formal recession last year, the Nigerian government said the contribution of oil to economic growth slipped slightly more than 2 percent. The government's Bureau of Statistics said at the time the economy, measured by gross domestic product, declined 2 percent year-over-year.

Nigeria emerged from recession in the second quarter, after five straight quarters of contraction. Year-overyear growth for 2017 was about 0.6 percent. Economists at the Organization of Petroleum Exporting Countries said Nigeria produced 1.8 million barrels of oil per day last month, up 19 percent from the 2016 average.

The NDA said some of its militants had switched sides and were now working with the Buhari administration. but it wouldn't stop its campaign until the Niger Delta was liberated.

"We can assure you that every oil installation in our region will feel warmth

of the wrath of the Niger Delta Avengers," it said.

Nigeria is a member of the Organization of Petroleum Exporting Countries exempt for a multilateral agreement to trim production to balance an oversupplied market. Nigeria asked for exemption so it can steer oil revenue toward national security efforts.

The emergence of President Muhammadu Buhari has brought with it a new hostility in the Niger Area of the country. The new hostility was expected as the President took some decisions and made some statements that were not attractive to the peace pact entered into by the previous administrations.

President Buhari started by cancelling contracts awarded to exmilitants by former President Goodluck Jonathan to protect oil facilities, not only that, the regime also threatened to stop the Amnesty programme whereby some amount of money was paid to ex agitators to resettle them and integrate them into the society.

As if all that was not enough President Muhammadu Buhari himself openly declared in an interview with a foreign Journalist that his administration was going to pay more attention to the areas that gave him more than 97 percent of his votes as against the area that gave him less than 5 percent of his votes. This was seen as an insults to Nigerians especially taken into consideration that apart from the fact that the money he was going to spend in office belonged to all Nigerians, the areas that gave him less than 5 percent of his votes actually is the area where oil the main stay of the nations economy reside.

So the militants have to attack to bring him back to senses in case



he had forgotten that the economy of the country is still in the NIGER DELTA area. A militant group in Nigeria says it has bombed three pipelines in the south of the country in the latest attack on the country's crucial oil industry.

In order to bring President Buhari to his knees a new militant group known as the NIGER DELTA AVENGERS was formed. The new group is different from the old warlords that just wanted more money and development projects in the Regions. The Niger Delta Avengers is said to exist in all the states of the South East and South South with the aim of making Nigeria ungovernable for the Muhammadu Buhari administration.

They have sympathy for former President Goodluck Jonathan administration and are not happy with the way he was voted out of office.

They believe his fall had some connection with Boko Haram leaders who vowed to make Nigeria ungovernable and they carried out their threat until Jonathan was disgraced out of office.

The Avengers want to revenge the Boko Haram attack in the South, make Nigeria ungovernable under Buhari hence the name Niger Delta Avengers.

Former President Jonathan may not have anything to do with the group but that if Nigeria is renegotiated issues like Power Rotation, Resource Control or outright breakup of Nigeria may be in their agenda as they go along. This make them different from the ex militants who only fought against environmental degradation in the oil rich region.

They are also said to have a relationship with the Independent People of Biafra [IPOB] and are being funded by some International Organisations.

With a name that sounds like it has come from the pages of a superhero comic book, the Niger Delta Avengers (NDA) is the latest militant group to emerge in Nigeria - attacking oil installations in a campaign which threatens the economy of Africa's most populous state.

'We are a group of educated and well-travelled individuals that are poised to take the Niger Delta struggle to new heights that has never been seen in this nation before," the NDA proclaimed in one of their first statement's on their website in April.

"We have well-equipped human resources to meet this goal."

It was not an idle threat. The NDA has carried out a barrage of attacks on oil installations in the Niger Delta region, causing a huge decline in oil production, which is the mainstay of the West African state's economy.

The NDA, the latest militant group to emerge in Nigeria, is demanding that a greater share of oil wealth be spent on ending poverty in local

communities.

Attacks resumed in 2016 after funding for former militants was slashed.

The NDA blew up three trunk lines carrying 300,000 barrels of oil a day to Shell's Bonny export terminal in southern Bayelsa state.

Destruction of oil installations by successive militant organisations have severely disrupted crude production.

But an amnesty programme for former militants led to a period of relative peace until earlier this year,

Talks to resolve the conflict have been taking place in recent months, resulting in a delicate ceasefire, but those talks stalled at the beginning of November 2015

Since then there has been a sharp increase in attacks.

The continued attacks on pipelines are slashing Nigeria's oil production - and hammering an economy reeling from its worst recession in years.

The government also announced a vague plan to invest \$1hn in the region - although it didn't spell out where the cash would come from.

Since the high-profile meeting, there have been a slew of attacks.

One of the militants told the BBC that the government was "playing with us" and that it wasn't putting its words into action.

Militant groups say they're fighting for a greater share of the resources for local communities. They also want the government to honour a previous amnesty programme - which offers cash payments and retraining after its budget was slashed by two-thirds at the start of the year.

The government, however, accuses the militants of holding the country to ransom.

The continued violence is designed to pressure the government into making an agreement.

Despite the enormous economic pain, the president stood his ground,

"The renewed activities of the militants in the Niger Delta is seriously affecting our oil production," Minister of Finance Kemi Adeosun admitted on state-owned NTA television.

Who is their leader?

This is the first armed group to emerge in the region where most people are poor despite the fact that it is rich in oil - since late Nigerian President Umar Musa Yar'Adua granted amnesty to militants there seven years

At the time, militants in the region said they wanted a better deal for their people who have suffered environmental degradation and economic dislocation because of oil production by some of the world's leading

Many of the militants were encouraged to drop their arms and agitation in exchange for some cash incentives and training. Former President Goodluck Jonathan, who comes from the Niger Delta, continued the scheme.

The amnesty programme, which provides tens of thousands of former oil militants with a monthly stipend from the government, stemmed the level of violence.

Last month, Shell declared a force majeure, which excuses a company from contractual agreements because events beyond its control, on exports of high grade crude oil after an attack on one of its trunk lines.

A few days later, US firm Chevron shut its Valve Platform following another attack, also claimed by the Avengers.

And ahead of President Buhari's first expected visit to the region, the NDA said it had blown up two Chevron export terminals.

l'hese attacks have dealt a buge blow to the revenue of the Nigerian government, which says the renewed activities of the militants are seriously affecting oil production.

In fact the country's production has dropped to 1.65 million bpd, as against the projected 2.2 million bpd.

The military has issued a stern warning that it will deal decisively with any group fermenting trouble in the country, including those it has described as "criminal elements in the Niger Delta".

But this appears to have

emboldened the Avengers into more attacks that have had a knock-on affect on the supply of electricity that. Vice President declared depends on gas from the oil-producing companies.

For President Buhari, administration the NDA presents another fresh security challenge to the government which has been grappling with Islamist insurgency in the north-east of the country.

As Nigerian troops continue to comb the entire Niger Delta regions and the creeks in search of ex-Militants over the new bombings of oil facilities by an organization known as Niger Delta Avengers our investigations has revealed that the group may not have anything to do the ex Militants after all.




























HON JUSTICE ZAINAB A. BULKACHUWA, CFR, PRESIDENT COURT OF APPEAL, NIGERIA

aking into account the generally unfavourable attitude towards girl child education prevalent during her growing up years in Nigeria especially in Northern Nigeria, it is no mean achievements that Hon Justice Zainab Bulkachuwa managed to rise academically and professionally to the pinnacle of her career. This has subbished the myth of the superiority of one gender over the other.

Her emergence as the first female. President of the Court of Appeal in Nigeria in April 2014, did not come as a surprise, it was a culmination of sterling records and her reputation as an upright Judicial officer. A woman that has not only carved a niche for herself, but has made a respectable name and reputation in the legal profession..

Young Zainab had her early education at Tundun Wada primary school Kaduna between 1957 and 1960 before proceeding to Senior Primary school where she obtained her School Leaving Certificate in 1963. She had her West African School Certificate from Queen Elizabeth School, Ilorin between 1964 and 1968 before proceeding to the Abdullahi Bayero college/ Ahmadu bello University, Kano between January 1971 and June 1972 for her GCE A level.

After completing her secondary education, she was given out in marriage at a relatively young age. For several young girls marriage would normally bring about the end or at least the suspension of their Educational carreer. This was not so for the young Zainab. Determined to continue her Education, she combined being a student with motherhood and child bearing. She had three of her six children while she was a student and during her National Youth Service.

Yet she performed brilliantly in both spheres. However she, she prefers to give the credit to her late father who agreed to give her out in marriage only on the condition that her husband allow berto continue her education despite being married. She also give credit to her late Uncle who ensured that her late father's wish was carried out.

An judigene of Nafada Local Government, Gombe state, Hon-Justice Zainab Bułkachuwa was born 6" March 1950 in Bauchi state, she is the daughter of Alhaji Abubakar Gidado El Nafaty and Hajiya Aishatu Dudu El Nafaty. countemporary of late sir Tafawa Balewa, her late father was an astute Educationist bruadcaster , fluent in Arabic. English, Fulfude and Hausa, he served as a controller of the Nigerian Broadcasting Corporation and was a co founder along with the late Sheikh Gumi and others of Jama'atu Nasril Islam.

With sound education and proper upbringing there is no telling how far a female child, just like her male counterpart can go in life, while a woman may marry early, marriage must not be a reason. to terminate her education career. As the society comes to terms with the importance of educating the girl child, the potentials of women and their capabilities unleashed for the greater good of the country and humanity.

She later proceeded to the Ahmadu Bello University, Zaria where she obtained her LL.B (Hons) between 1972 and 1975. Between 1975 and 1976 Bulkachuwa had her programme at the Nigerian Law School before being called to the bar in 3" of July

An integrity driven woman, Justice Bulkachuwa believes in hard work, truthfulness and Integrity

and has attributed success in the legal system to all these. " Integrity pays, I have based all my life in putting Integrity first in all that I do right from my childhood days, the teaching from my parent was the foundation of what am today." She said.

A woman with formidable profile and Charismatic personality, after the completion of her LL.B (Hons) from ABU Bulkachuwa service traits, exemplary commitment to duty and outstanding leadership qualities manifested throughout her service years.

In 1996 when Gombe state was created she had the unique honour of being appointed as the Chief Judge of the state from 1997 to 1998. In 1998 she was elevated to the Federal Judiciary as a Justice of the Court of Appeal. Between 2005 and 2012 she was the presiding Justice over the court of Appeal until she became acting President of the same court in November 2012. She was eventually confirmed as the President of the Court of Appeal in April 2014. By that appointment she became the first woman in the Legal History of Nigeria to serve as the President of the Court of Appeal.

Over the years Her Lordship has not only actively worked in the Nigerian Judiciary, she has played several oversight, and participatory roles on several other national platforms including Legal Adviser Federation of Muslim Women Association of Nigeria from 1988 to 1990, President OSOQUES, Bauchi , Member Board of Governors of the National Judicial Council from 1997 to 1998, member Body of Benchers 1997 to 1998, President National Association of women Judges 2000 to 2003, Initaitor of the Jurisprudence of Equality project 2001 to 2008, member of the Nigerian Rule of Law Assistant project between 2003 and 2005, acting Chairman of the Legal Practitioner's Disciplinary Committee.

WORKING EXPERIENCE:

On completion of her National Youth Service, His Lordship joined the public service as Pupil State Counsel Grade I. Following her service at the Ministry of Justice in Kaduna, she was elevated to the Bench: first as Magistrate Grade I, then Senior Magistrate I & II before becoming Chief Magistrate II all between 1980 and 1985 in the Kaduna State Judiciary. It was during this period that she attended Yale University, Connecticut, USA as a Visiting Scholar for 3 months.

In 1986, she continued her career in the Bauchi State Judiciary first as Chief Magistrate I and then as Deputy Chief Registrar to later become Acting Chief Registrar, Her late husband, Prof. Abubakar Yaya Aliyu began his career as a Research Assistant to the Vice Chancellor of the University of Lagos. However, he died in 1987 when Appeal. she was appointed a Judge of the High Court of Bauchi State.

She married Ambassador Adamu Bulkachuwa in 199, He is now the Sarkin Bai Katagum and the District Head of Bulkachuwa.

In 1996, when Gombe State was created, she had the unique honour of being appointed as Chief Judge of Gombe State Bulkachuwa. Judiciary from January 1997 to December 1998, In 1998, she was elevated to the Federal Judiciary as Justice of the Court of Appeal. Between 2005 and 2012, she was Presiding Justice of the Court of Appeal until she became the Acting President of the same Court in November 2012. She was eventually confirmed as the President of the Court of appeal on the 17" of April, 2014. By that appointment, she became the first Woman in the Legal history of Nigeria to serve as the President of the Court of

Governor Wike spoke on Monday at the Royal Institute of 22% to the entire 36 States of the federation. International Affairs (Chatham House), London when he delivered a locture on the topic: "Defining Development for Rivers State and Steps - revenue is disaggregated among 36 States, what comes to Sustainable Implementation*.

The governor said: "There is need for the international community average per annum, which by any stretch of to save the country and its democracy from imminent collapse by imagination is incapable of funding serious

"The fact cannot be disputed that States bear Government. However, under the flawed revenue retains 53% of national revenue and allocates only

"Obviously, when 22% percent of national to each State is not more than 0.6 per cent on the developmental programmes for any State".

He said the country is in serious political and economic decline, pointing out that Nigeria is presently caught up in a serious existential crisis, which is self-evident.

According to Governor Wike: "The politicization and active involvement of key national institutions, such as the Independent National Electoral Commission and the Police in the rigging of the re-run elections in Rivers State was not only an affront to democracy, such acts constitute a serious invitation to chaos with destructive consequences of unknown dimensions".

The governor explained to the International Community that despite generating a huge percentage of the nation's resources, Rivers State has suffered untold neglect and deprivation by the Federal Government over the years.

He said: "As an integral part of the country Rivers State is entitled to development support from the federal government through the direct provision of projects and programmes in the State. This is even more so considering the State's enormous contributions to the national revenue bowl. Unfortunately, this is not the case as the Federal Government continues to neglect and marginalize the State in the provision of development projects.

"For instance, the Federal Government has not undertaken any new development project in the State for the last two decades. Even the existing ones, such as the Port Harcourt international airport, the two scaports and the liast. West highway have severely degenerated without attention for years. These are important economic projects that needed to function maximally to drive the socio-economic development of the State, yet the Federal Government continues to turn a blind eyes to

them with impunity*.

Governor Wike lamented the developmental challenges that have bedevilled Rivers State, despite her He said though enormous resources. previous administrations have played key roles in developing the state, the immediate past Amaechi administration stagnated development through unbridled theft of state funds during an era of resource boom.

" Although successive governments tried to move it forward, the eight years of the immediate past government were the most regrettable in the State's history as there were no tangible achievements to justify the huge resources that accrued to the State during the period of unprecedented oil boom. In stead, so much public money was either siphoned into private pockets or wasted on bogus and unsustainable projects*, he said.

He informed that despite the ugly state that the Amaechi administration left the state, his administration has over the last 29months embarked on meaningful development projects and programmes in the areas of infrastructure, human capital

development and security of lives and property.

He said: "We picked up this challenge as a matter of urgent priority by launching the "operation zero pothole programme" on our first day in office, which has successfully repaired and cleared most of our streets and roads of potholes.

'Thereafter, we dedicated an unprecedented 65% of the State's rapital expenditure to the provision of infrastructure. As at today, we have committed over 170 billion naira to construct. upgrade and expand several roads, bridges and jetties and linking up communities and settlements across the entire State".

The governor added:
"We increased public spending on education from 4.2% to about 10% on the average and deployed substantial resources for the renovation and equipping of over 180 basic education and secondary schools across the State to improve the quality of education at that level.

"We have also constructed, upgraded and rehabilitated several faculty buildings, lecture halls, workshops, staff offices as well as student hostels in all the tertiary institutions. These interventions have expanded access.



improved quality and placed our terriary institutions on the path to producing the skillful and innovative graduates that we need to drive the development of the State and the nation.

"Within the last two years of our administration, we have renovated 13 general hospitals in 13 local government areas of the State, established a teaching hospital for the State University to train medical personnel as well as restarted work on the construction of 3 regional health facilities and a mother and child hospital which were started but abandoned by the previous administration.

"We recognize the importance of the private sector in the healthcare delivery system. Consequently, we have also supported private hospitals in the State with interest-free revolving loans to enable them to improve their facilities and deliver better services to the public".

Governor Wike said despite the man-made challenges confronting his administration, the Stare Government has proved than

" a committed government can even in a short period impact positively on the State's sustainable development."

Governor Wike declared: "I want to assure you that our resolve is strong, our commitment to Rivers State and our people remain unchanged and unchangeable. We shall continue to do our best within the limits of available resources to deliver on our development priorities to the State on sustainable bases and enhance the wellbeing of our people."

Chair of the presentation , Sir Richard

Gozney KCMG CVO, Lieurenant Governor, Isle of Man; British High Commissioner to Nigeria (2004-07) noted that Rivers State is important to the development of Nigeria and plays a significant role in regional affairs.

Incumbent British High Commissioner to Nigeria, Mr Paul Awkright who attended Governor Wike's presentation urged him to continue to work for the improvement of security in the state for the increase in foreign direct investments.

Responding to questions from the diverse audience, Governor Wike regretted that the Ogoni clean up has been politicised by the APC Federal Government, pointing out that the administration had no intention of executing the project.

On foreign scholarships, Governor Wike reiterated that the State Government will pay for final year students in critical science courses, while those studying arts courses were advised to return to Nigeria with the Rivers State Government footing their bills.

ice President Yemi Osinbajo has presented a certificate for the Formal Release Ceremony to discharge Indoruma Eleme Petrochemicals Limited, (IEPL), from the mandatory five-year Monitoring Programme of the Bureau of Public Enterprises (BPE).

Presenting the certificate to Indocuma at the company's premises in Eleme, Professor Osinbanjo said 75% of Eleme Petrochemical Limited's equity was sold to Indorama for \$225million while 10% was sold to the NNPCPension Fund for \$30million.

He said following the transaction, the company was handed over to its new owners on October 26, 2006.

He said the National Council on Privatization (NCP) in 2009 approved the sale of 7.5% and 2.5% of the remaining government's 15% reserved equity in the company to the community and staff of the company respectively, saying that a balance of 5% was left with the BPE on-behalf of the Federal Government of Nigeria.

He said "Following the 2006 handover, the BPE carried out routine monitoring on the enterprise to ensure that the core investor adhered to and implemented the post-acquisition plan it had laid out for the company"

Today is the culmination of that process of monitoring and oversight by the BPE. I am delighted that it is taking place on an inspiring and hopeful note, and that we are all here today celebrating a thriving and promising company"

He said President Buhari last year established a Presidential Enabling Business

Environment Council(PEBEC), whose results he said are "now starting to be felt across the country."

According to him "The kind of economic growth and prosperity that we're aiming for cannot happen without private capital, and that private capital cannot beunlocked without reforming the business environment by removing obstacles and roadblocks to investment and to business operations."

He added "We know for a fact that it is impossible for government to ever be able to provide all the capital needed to invest in infrastructure, or to catalyse economic activity. The best that we can do, and what we should be putting all our energy into, as government, is acting as a catalyst, an enabler, supporting private capital to achieve maximum impact in an economy that so desperately needs all the investment in can get"

He said the journey to realise the project has taken over 3 years saying that they were able to achieve their objectives despite the initial obstacles.

He said with a total of \$1.4bn in the plant, pipelines and export terminal the fertilizer company is one of the largest investment done in the non oil oil and gas sector.

Rivers State governor, Nyesom Wike said the State government has an investment interest in the company saying that it will continue to support the company.
